Inflammation Research (IR) is the official journal of the International Association of Inflammation Societies (IAIS). It serves as the publication and communication platform for all societies associated with the IAIS and the Editorial Board consists of representatives of many of these societies.

IR is, therefore, an ideal means for society members to publish their research in an internationally well-respected journal and to make sure that their results are distributed to the inflammation community. Original research papers, reviews, short communications, commentaries, reviewed society proceedings and meeting reports on all aspects of inflammation and related fields are welcome for publication. Subject coverage includes histopathology, immunological mechanisms, gene expression, inflammatory mediators, experimental models, clinical investigations and the effects of drugs. Related fields include allergy and asthma, shock, pain, joint damage, skin diseases as well as clinical trials of relevant drugs.

In its function as official journal of the IAIS, the journal also publishes letters, opinions, news of scientists, policies and general information related to the societies active in these fields.

IR is a modern journal, well established in the electronic world. It offers services which ensure easy on-line submission and tracking of manuscripts throughout the peer-review process (Manuscript Central), quick time-to-publication (Online First), and high visibility and usage of the articles by being connected to the big abstracting and indexing services. Online First: Quick publication time due to this service which provides access to the electronic version of peer-reviewed articles well before print publication. Online First articles are searchable and citeable by their DOI (Digital Object Identifier) and hence significantly reduce the time to publication.

Editor's Choice: Free access for 3 months to topical full-text articles right after publication, selected by the Editor-in-Chief Prof. Dr. Michael J. Parnham.

Open Choice: This option offers authors, against payment of a basic fee, to give worldwide free access (Open Access) to their peer-reviewed and accepted article in electronic form via the internet database SpringerLink. The authors keep the copyright of the article in this case.

Abstracted/Indexed in all important databases:

Manuscript Central: A fully web-based online manuscript submission and review system is available to authors. This system offers authors easy and straightforward login and submission procedures and the option to track the progress of the review process of manuscripts in real time.

Inflammation Portal: This internet portal provides free access to all abstract issues from past inflammation conferences of the IRA since 2000 and the IAIS since 2005.

Furthermore, it offers links to many important inflammation societies, society announcements, links to important inflammation-related meetings, and further Springer Basel journals and book series of interest (free access via the journal's website: www.springer.com/11).
